ORDER

3. **Vigilance/Disciplinary case, if any**

No. 25-19/88-SPG dated 13.10.1992 is pending against any of the officers, he should not be relieved for posting without obtaining specific orders from this office. The officers against who any punishment is current should not be promoted before expiry of currency of punishment. A report in this regard should be submitted immediately.

4. **Fixation of Pay**


All the officers who wish to give option for choosing date for fixation of pay under FR-22(1)(a)(1) should do so within one month from the date of assumption of charge.

5. **Officers allotted out of their present circle**

The circles of allotment will immediately issue posting orders and **in any case not later than 26.07.2010**. The present circles of such officers, who have been posted to another circle on promotion, **will immediately relieve the officer on receipt of posting orders, unless they submit unconditional declination**. The CPMSG of the circle of allotment/present circles will personally ensure issue of posting orders by the due date and immediate relief of the officers. **Despite issuance of posting orders, if any officer does not join within one month from the date of issue of posting orders, it will be presumed that he has declined the promotion and this should be brought to the notice of this office immediately.**


